# **EMERGENCY MANAGEMENT** A.A.S. (CAREER)

#### **Program Description**

Provides students with a broad education in emergency management. Focuses on preparedness and the skills needed to organize and lead emergency management operations.

After completing the required FEMA IS prerequisites, students enroll in the following courses: EMGT 105, EMGT 115, EMGT 125, EMGT 135, EMGT 140, EMGT 215, EMGT 225, and EMGT 235. *Students must earn a grade of 'C' or better in these EMGT courses.* These are FCC online courses offered during the fall, spring, and summer semesters.

Convert FEMA IS prerequisites to Frederick Community College (FCC) credits directly via MACEM&PS.

### **Program Requirements**

- Students must complete their credit **English and Mathematics** within the first 24 credits.
- One course must meet the cultural competence graduation requirement (https://frederick-public.courseleaf.com/generaleducation-core/#cultural).
- CORE: The General Education CORE is that foundation of the higher education curriculum providing a coherent intellectual experience for all students. Students should check with an advisor or the transfer institution (ARTSYS) before selecting General Education CORE requirements. http://artsys.usmd.edu/
- In some General Education categories (Mathematics, Biological & Physical Sciences), a 4-credit course selected from the GenEd course list will satisfy the requirement in place of a 3-credit course. Students should check with an advisor before selecting these courses.
- For the Physical Education, Health, or Nutrition requirement, a 3-credit PHED, HLTH, or NUTR course may satisfy the requirement in place of a 1-credit course. Students should check with an advisor before selecting this course.

- Students must earn a grade of "C" or better in ENGL 101 English Composition.
- Students must earn a grade of 'C' or better in the following courses: EMGT 105 Public Safety Written Communication, EMGT 115 Foundations of Emergency Management, EMGT 125 Emergency Management Coordination, EMGT 135 Leadership and Management, EMGT 140 Crisis Animal Care & Planning, EMGT 215 Planning and Response, EMGT 225 Emergency Management Mitigation, and EMGT 235 Recovery, Assessment, and Exercise.

## **Guided Pathway to Success (GPS)**

Suggested schedules map your path to degree completion.

Students in the Track I pathway often have General Education transfer credit, which may allow them to address core requirements faster, or at different times, than shown in this sequence. Further, the 5-week online format of many of the listed EMGT courses allows potential program completion much more rapidly than listed here, and out of sequence with traditional Gen Ed coursework. It is strongly recommended that all students work with a program advisor each semester to carefully select and sequence courses in the most advantageous fashion for their unique circumstances.

FEMA Elective credits may be completed and converted via MACEM&PS (https://macem.org/Independent-Study-Credit-Conversion-Programs.aspx) at any time. This point in the Pathway is simply a good time to assess progress and plan for completion of any outstanding FEMA credit needs.

Students interested in pursuing an internship (INTR) to work toward their Extension Electives should contact the Program Manager for guidance about the process.

Note: Completion of appropriate listed FEMA coursework (via FEMA Independent Study courses and credit conversion through MACEM&PS (https://macem.org/Independent-Study-Credit-Conversion-Programs.aspx)) is necessary before enrolling in associated EMGT courses. Specified EMGT courses are requirements; completion of FEMA IS courses will not by itself result in an FCC credential.

### **Part-time Students**

Part-time students should complete courses in the order listed on the pathway. Please contact program manager for questions about part-time status.

Students who take fewer than 15 credits each semester or who require developmental English or Math coursework will need additional semesters to complete their degrees. Summer term and January session classes may help students to make faster progress.

#### Pathway Legend

Milestone - courses with the Milestone notation should be taken within the recommend credit range to stay on track for program completion.

Fall, Spring, Summer - courses with a Fall, Spring, or Summer notation indicate the course is offered in the specified semester only.
